Forgiveness

"Everyone thinks forgiveness is a lovely idea until he has something to forgive."

- C.S. Lewis

Is the daily practice of (repentance + forgiveness) a defining characteristic of your family relationships?

If there is no forgiveness, your family will definitely be miserable and probably be temporary.

The Sinfulness of Humanity + The Proximity of Family = Forgiveness or Bust

"Unresolved rifts can precipitate chronic stress in one or both participants that undermine their emotional and physical health. The resulting anxiety or depression can worsen heart disease and diabetes, cause reproductive problems, undermine immunity, and even shorten the person's life."

Matthew 18:21-35

Three Approaches to Forgiveness Today:

Theology Lesson - Forgiveness, but without justice.

- God created a moral universe where there is "right and wrong".
- When a wrong is done, and someone has to pay for the damage.
- CF always costs the victim because it means absorbing at least some of the debt.
- CF heals the victim with Christian love.
- CF never undermines social justice (which would be unloving to the community/family).
- CF never undermines restorative discipline (which would be unloving to the sinner).

Three Approaches to Forgiveness Today:

- c. No forgiveness

Theology Lesson - Forgiveness, but only after justice.

- CF is an act of grace.
- CF is a gift not a reward.
- CF is based on the character of the giver, not the worthiness of the recipient.
- CF is offered from an experience of divine forgiveness by the power of God in the hope of healing for the sinner.
- Eph 2:8-9 "God saved you by His grace when you believed... it is a gift from God."

Theology Lesson #3 - No forgiveness.

- CF is commanded so sinners can live in community for now.
- 1Pt 4:8 "love covers a multitude of sins"
- CF is commanded so victims can be at peace for now.
- Rom 12:19 "Never take revenge. Leave that to the righteous anger of God."

\$60,000 x 10,000 units = \$600,000,000

LUKE 23:34

Then Jesus said, "Father, forgive them; for they do not know what they are doing."

- Roman soldier – 23:47 - When the Roman officer overseeing the execution saw what had happened, he worshiped God and said, "Surely this man was innocent."

- The crowd – 23:48 - And when all the crowd that came to see the crucifixion saw what had happened, they went home in deep sorrow.

- The Religious Leaders – 23:50-54 - [Joseph, a member of the Jewish high council] went to Pilate and asked for Jesus' body. Then he took the body down from the cross and wrapped it in a long sheet of linen cloth and laid it in a new tomb that had been carved out of rock.

- The Criminal – 23:42-43 - Then he said, "Jesus, remember me when you come into your Kingdom." And Jesus replied, "I assure you, today you will be with Me in paradise."

Then Peter stepped forward with the eleven other apostles and shouted to the crowd... "Each of you must repent of your sins and turn to God, and be baptized in the name of Jesus Christ for the forgiveness of your sins." ... about 3,000 in all were added to the church that day.
